It also provides a link between scientific laboratories and industrial establishments for transfer of technologies through National Research Development Corporation (NRDC) and facilitates investment in R&D through Central Electronics Limited (CEL).

- Providing Support and Creating an Enabling Environment for Development & Utilization of New & Innovative Technologies.

- **DSIR is the authority that recognizes industrial R&D units (which enable them to seek customs duty concessions and also be eligible for SBIRI grants etc)**
